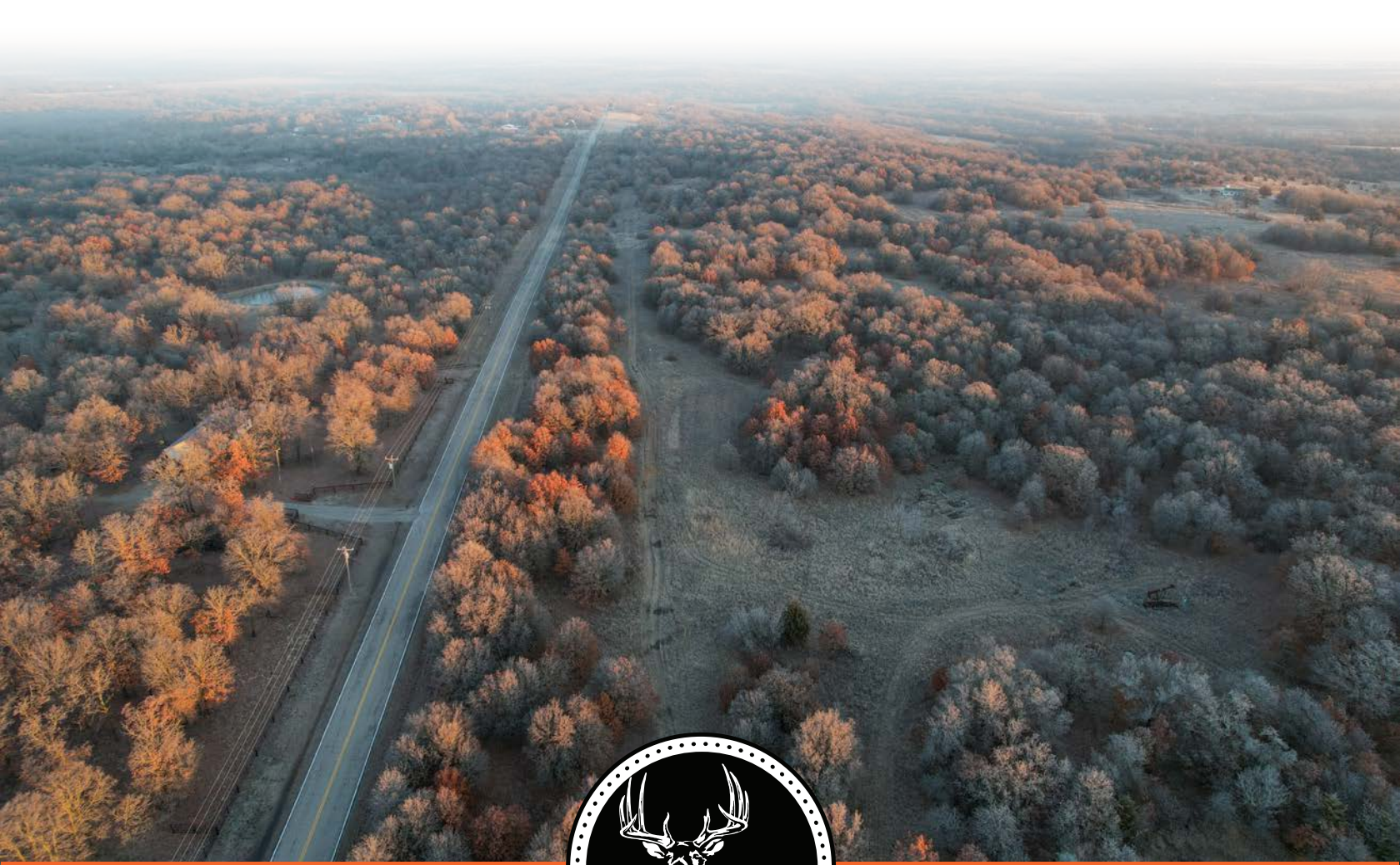

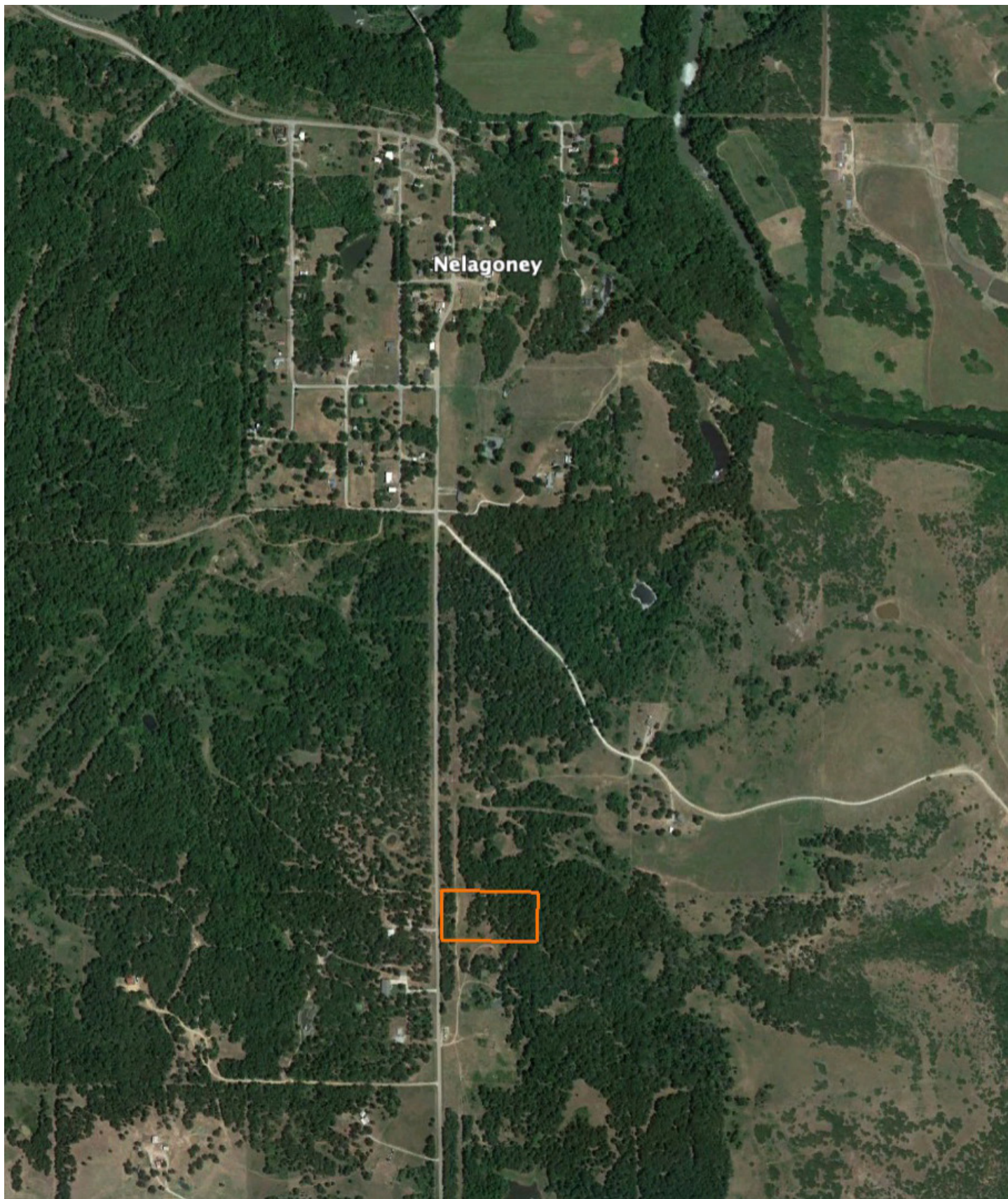

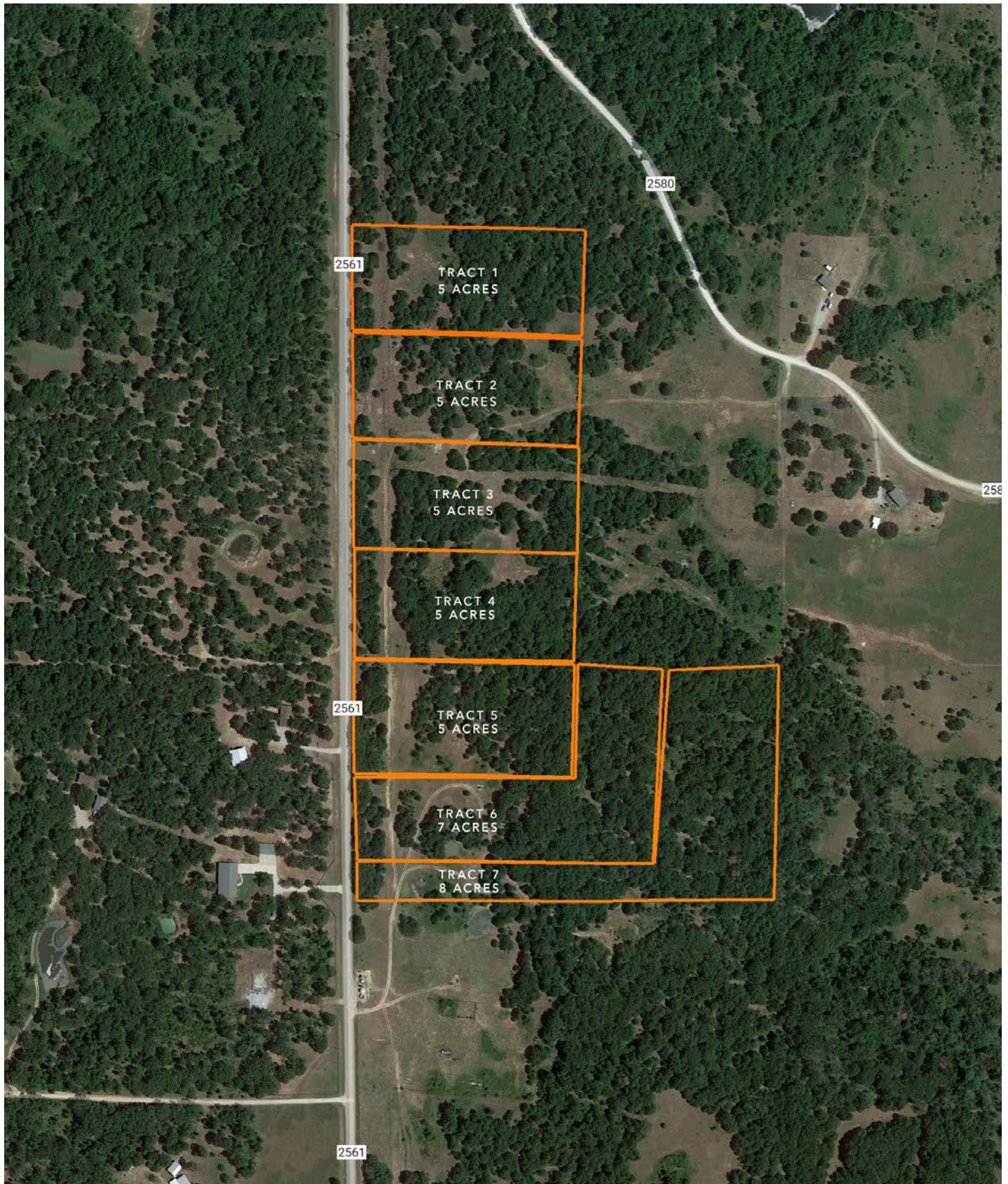
AERIAL MAP
