This property along with many others surrounding it underwent a large timber harvest about five or six years ago. The timber harvest has allowed native grasses, forbs, and other hardwood saplings to flourish throughout the understory of the entire property creating some great habitat for wildlife. The benefits of the increase in both food and cover can be seen in the seller's trail camera history on the property. Over the past several years there's been some great whitetails as well as black bear and turkey on the property. This property is located within the Missouri Department of Conservation's BMZ (Bear Management Zone) 1. This gives the owner the opportunity to draw a bear tag for Missouri's limited bear season. The property has enough flat space for a couple of small food plots and has plenty of acreage in thick security cover which deer will seek during the fall and winter months. There is an easement along the northern boundary of the property that will allow the owner to access the entire northern portion of the property.
