LANDERS CREEK 35 +/- ACRE HONEY HOLE

This 35 +/- acre property is located in west central Linn County, Kansas. The property has 6 +/- cropland acres primarily consisting of Dennis and Verdigris silt loam soils that have an NCCPI overall weighted average of 77. The cropland acres have been seeded to a wildlife food plot mix for this year, and do not have a tenant farm lease agreement currently in place. The remaining 29 +/- acres are loaded with cover, including giant hardwoods, cedar thickets, and tall warm-season native grass edges. The timber stand also includes a great number of marketable walnut trees. Landers Creek winds throughout the south side of the property, providing a year-round water source and natural wildlife travel corridor. The north ridge of the property is a south-facing slope that sets up well

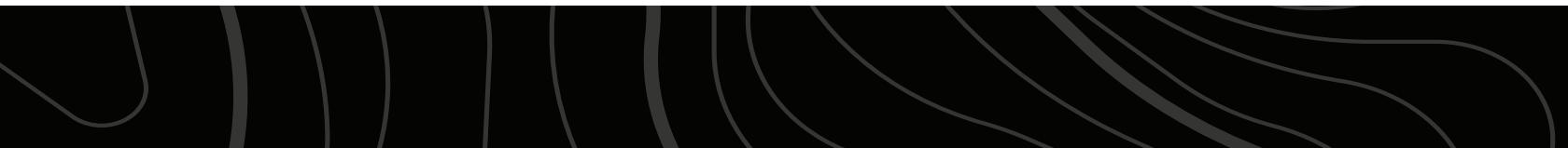
for a whitetail winter bedding area. The property's diverse habitat with abundant food and water creates some of the best whitetail deer, turkey, and upland bird hunting that Kansas is known for! The property is located in Kansas Deer Management Unit 11, and has excellent whitetail deer and turkey numbers! There is a very extensive and established trail system throughout the entire property. The property is located on a well-maintained, year-round gravel road with electricity at the road. This property is a must-see to truly appreciate all of the hardwood timber diversity and recreational value it holds! 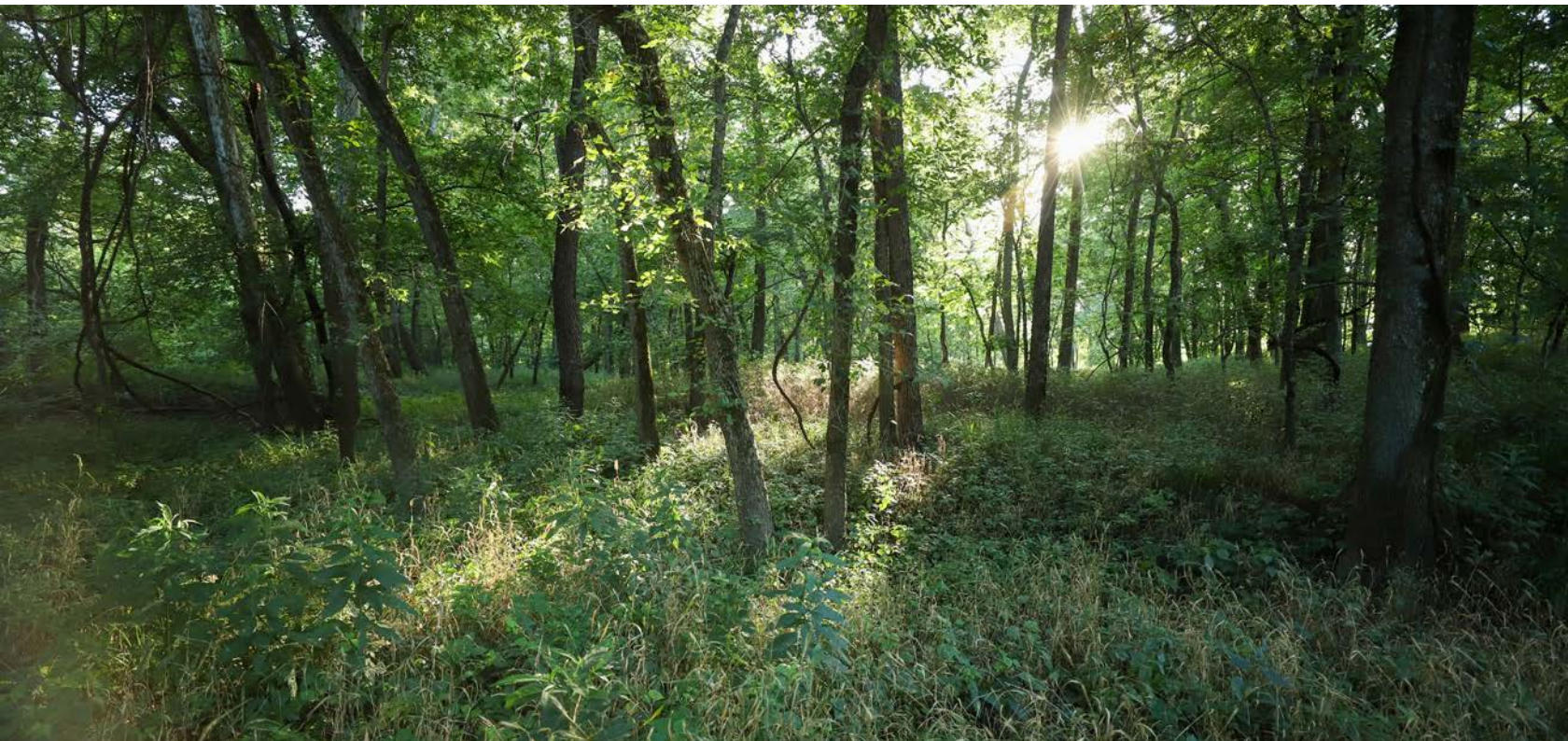

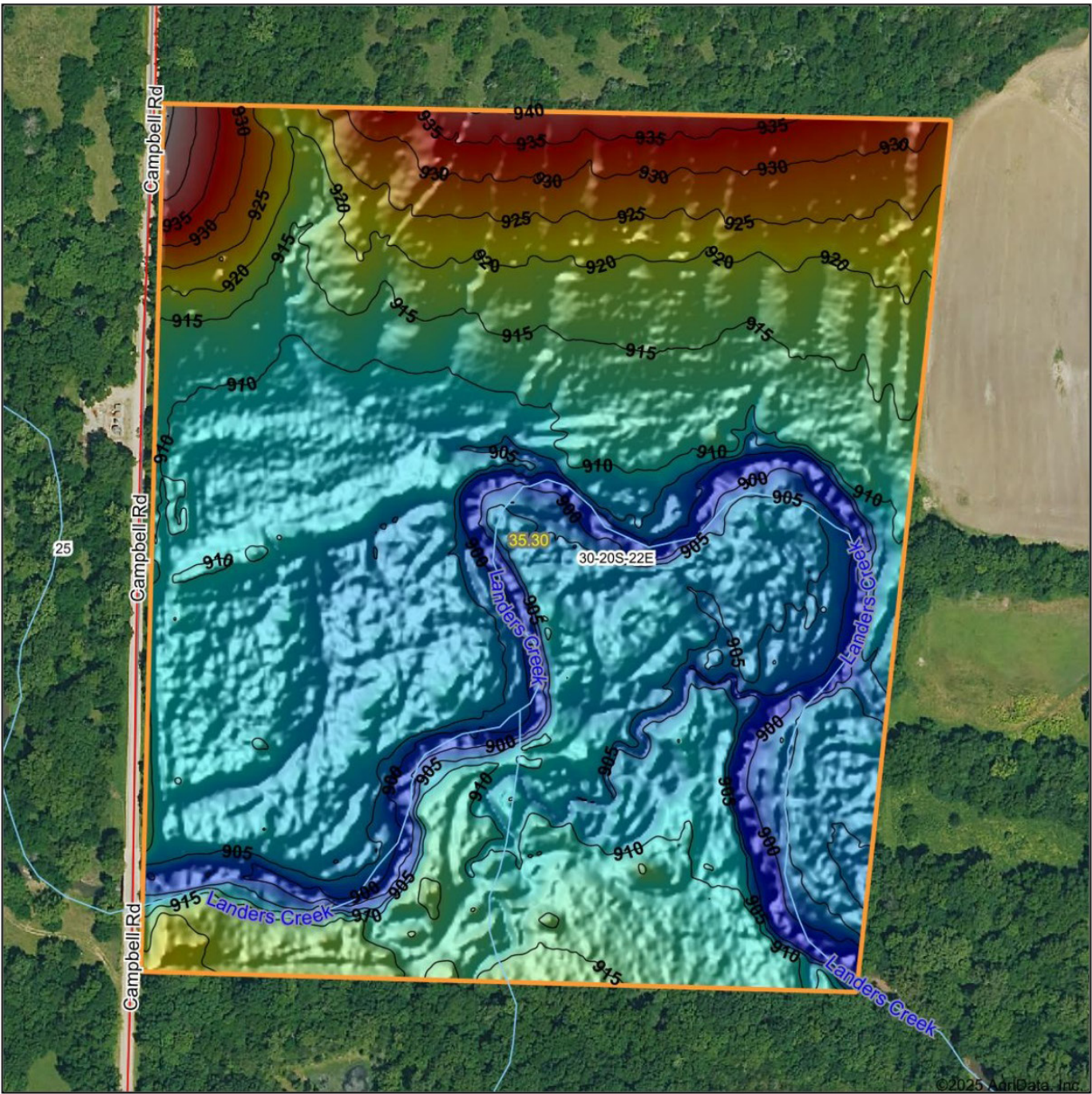

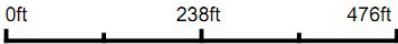

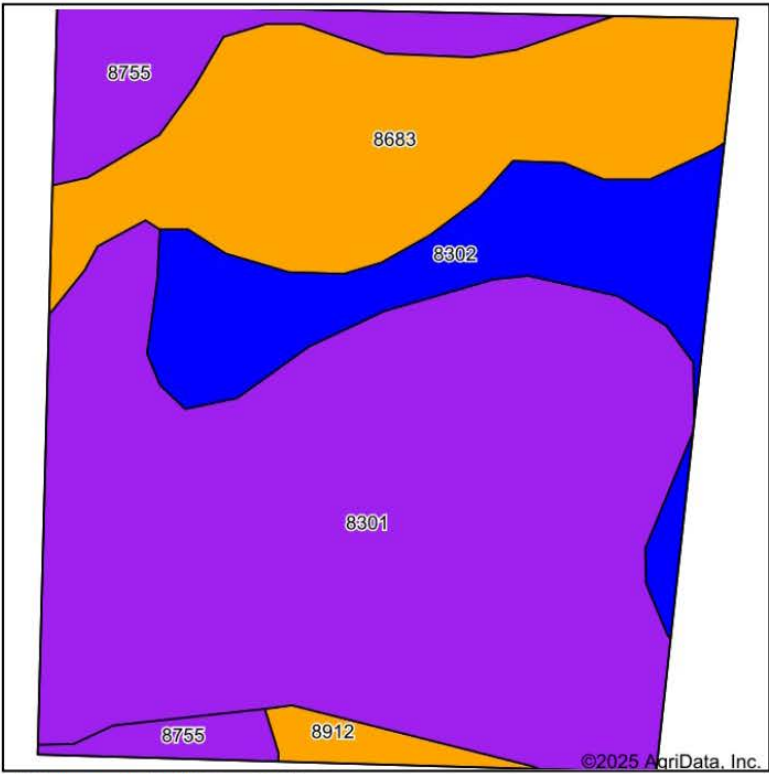

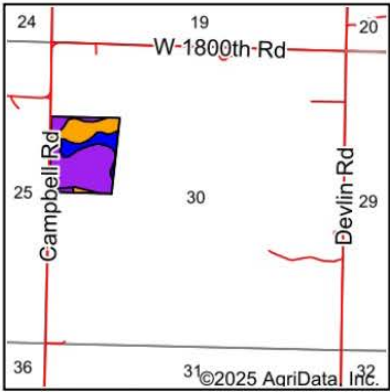
