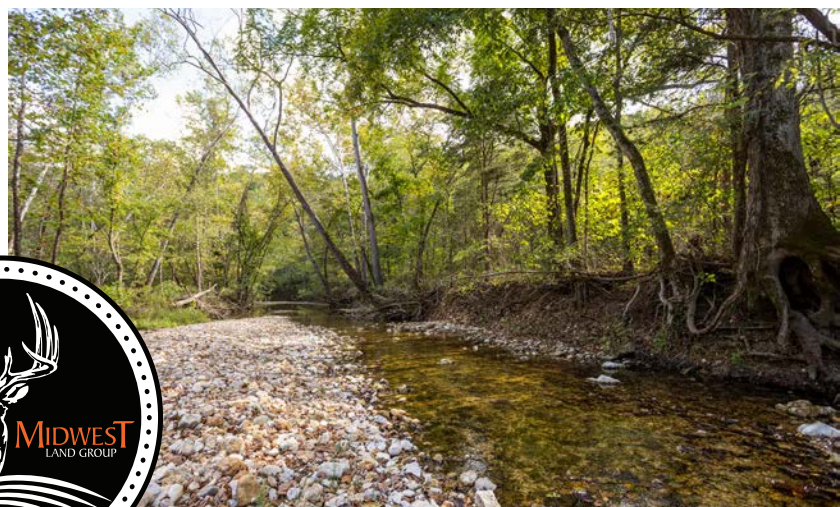

This secluded hunting retreat has been a family treasure for the current owners for many years. It's not often that an opportunity comes along at such a turn-key setup.

Situated just past the end of State Highway AA, near Caney Creek, lie these 69 acres. The property is bordered by a dead-end county road on the north and south boundaries, allowing for multiple ingress and egress options. A 1,100' driveway leads you to a rustic 40'x50' cabin, perfectly situated in a secluded and stunning ridgetop setting. As you approach, you'll be greeted by views overlooking a spring-fed creek that winds below the driveway, a sight that truly must be experienced in person to be fully appreciated. The cabin itself features a spacious wrap-around porch, inviting you to relax and enjoy the surroundings. If you're running late to the deer stand, it's suggested that you finish gearing up on the front porch and keep your rifle close by.... you're likely to see deer cruising through within range of the cabin. Inside, you'll find an open concept living, dining, and

kitchen area, with enough space for multiple beds or bunks. The layout also includes a separate bathroom and shower room, an attached carport for convenience, and a private well and septic system. The oversized well house doubles as a storage shed, adding some extra functionality.

The 69 +/- acres are comprised of about 54 acres of hardwood timber draws and ridges, and about 14 acres of ridgetop pasture. The pastures allow for some incredible potential food plot locations, and the timbered acreage has some great white oak timber on it. The property has a great trail system, allowing you to traverse through most of the property with a truck or UTV. There is a beautiful spring-fed creek below the cabin, and there is one wildlife pond in the center of the property. Additionally, the property has an incredible 160-degree view up on the south pasture, and nearly 400' of Caney Creek frontage. If you've been searching for a turn-key hunting camp and want to experience the joy that this property has brought the current owners for many years, this is the property for you. 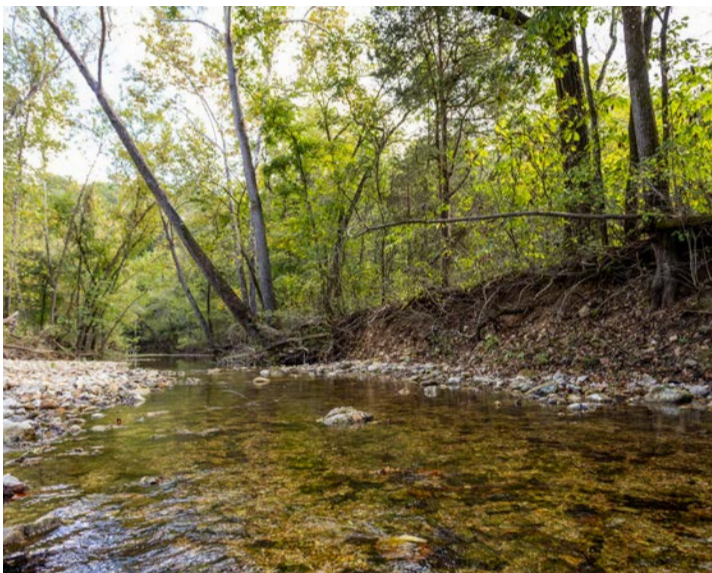

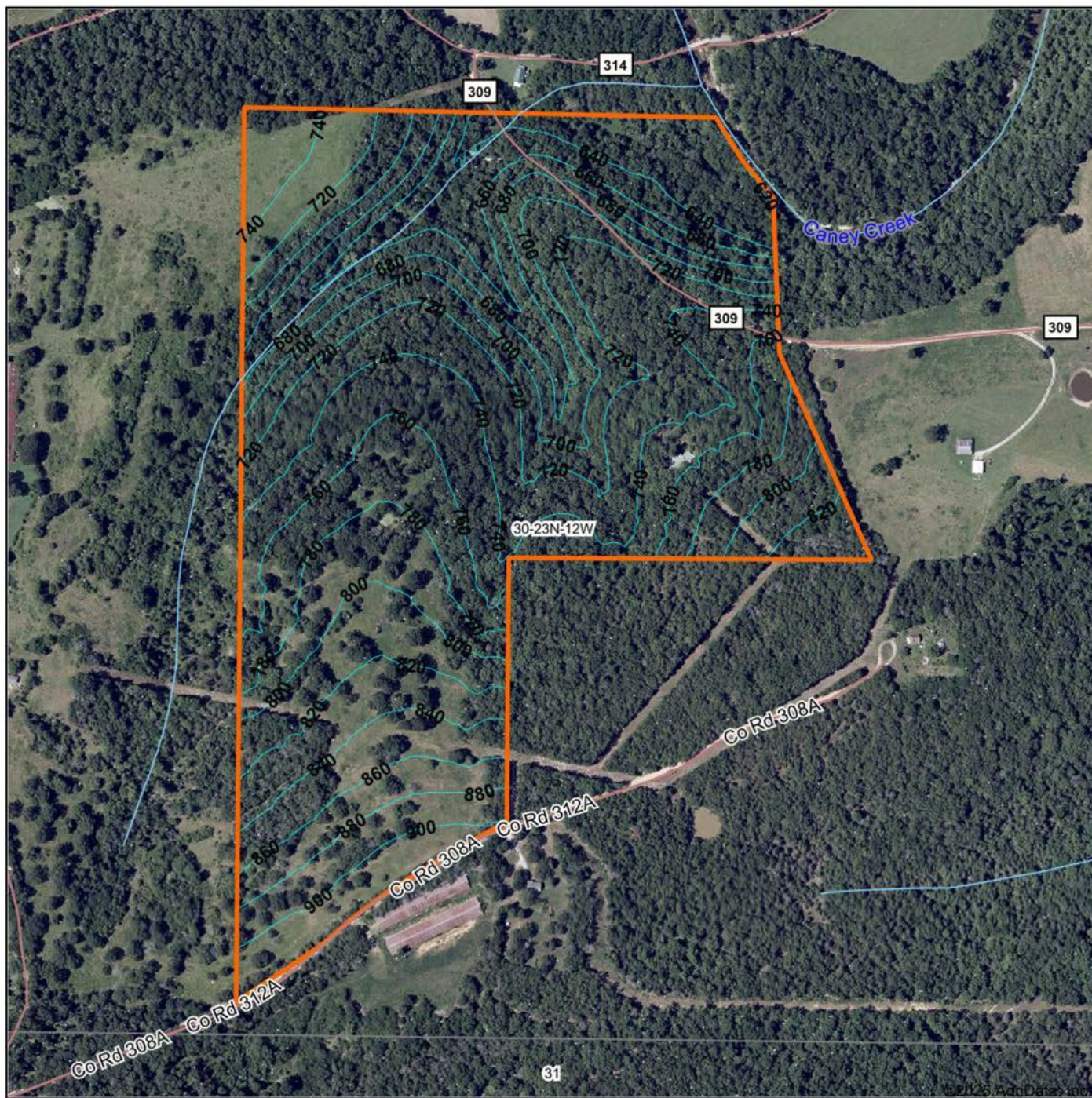

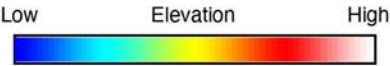

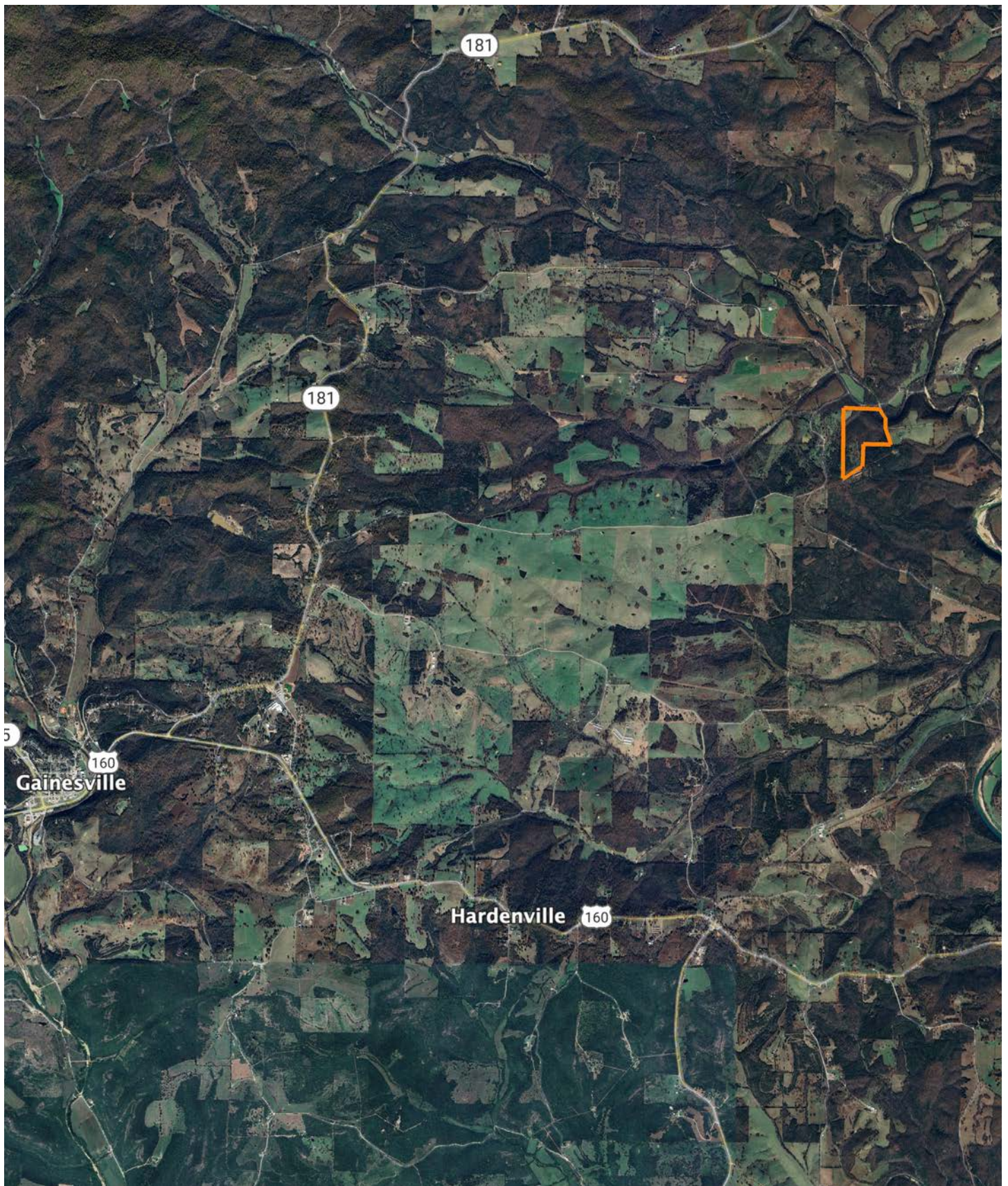
