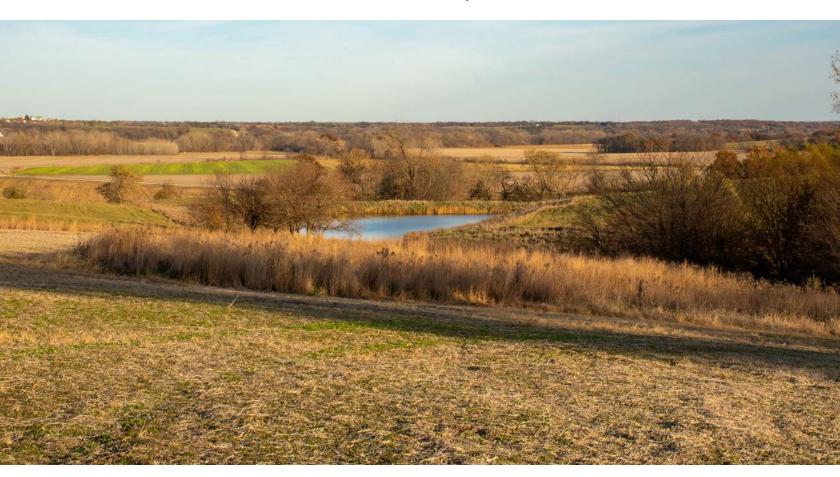

A hunting property this good, 1.5 miles from the Iowa border, rarely becomes available. Schedule your showing today.

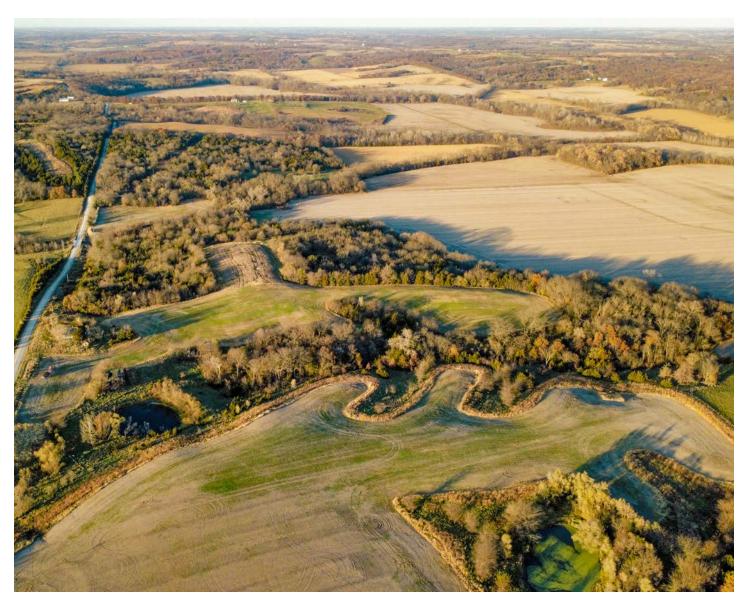

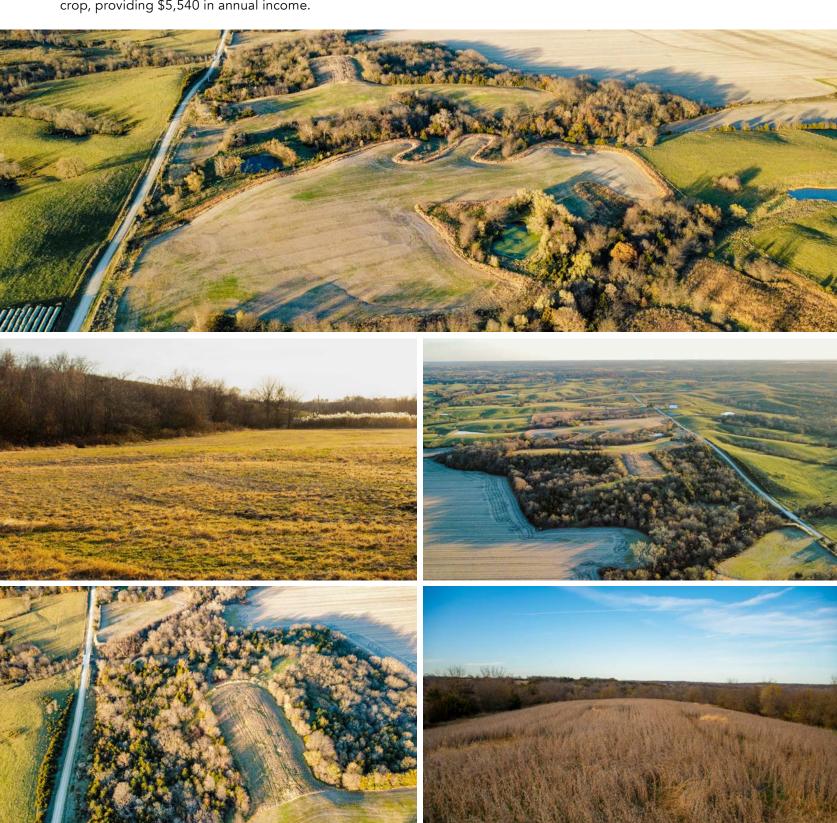

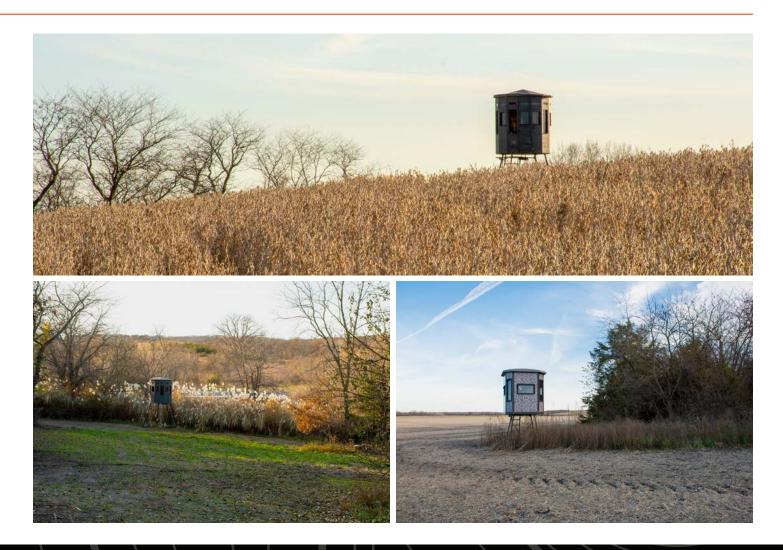

MISCANTHUS GRASS AS NATURAL BARRIER

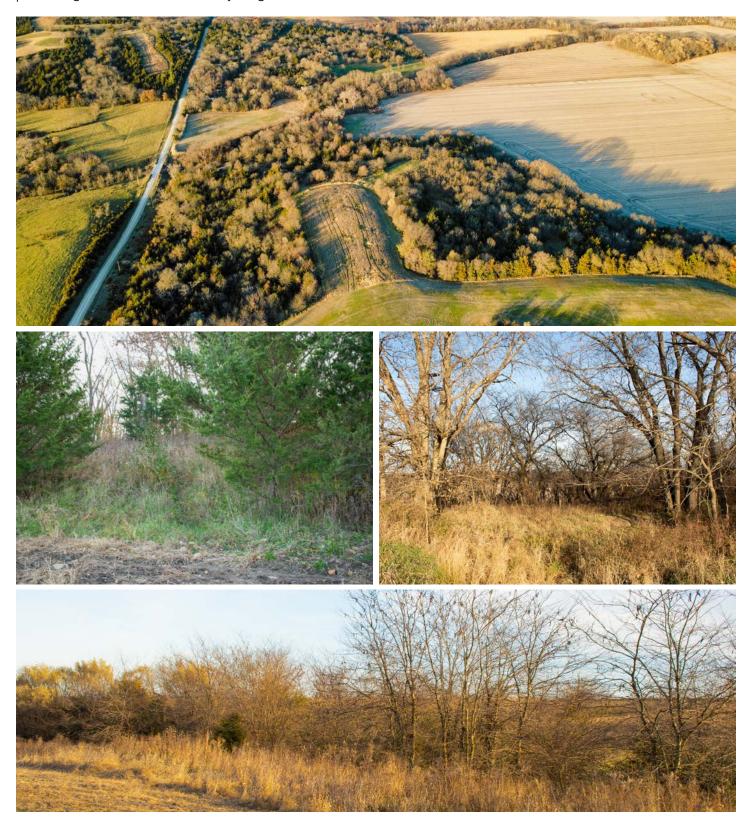

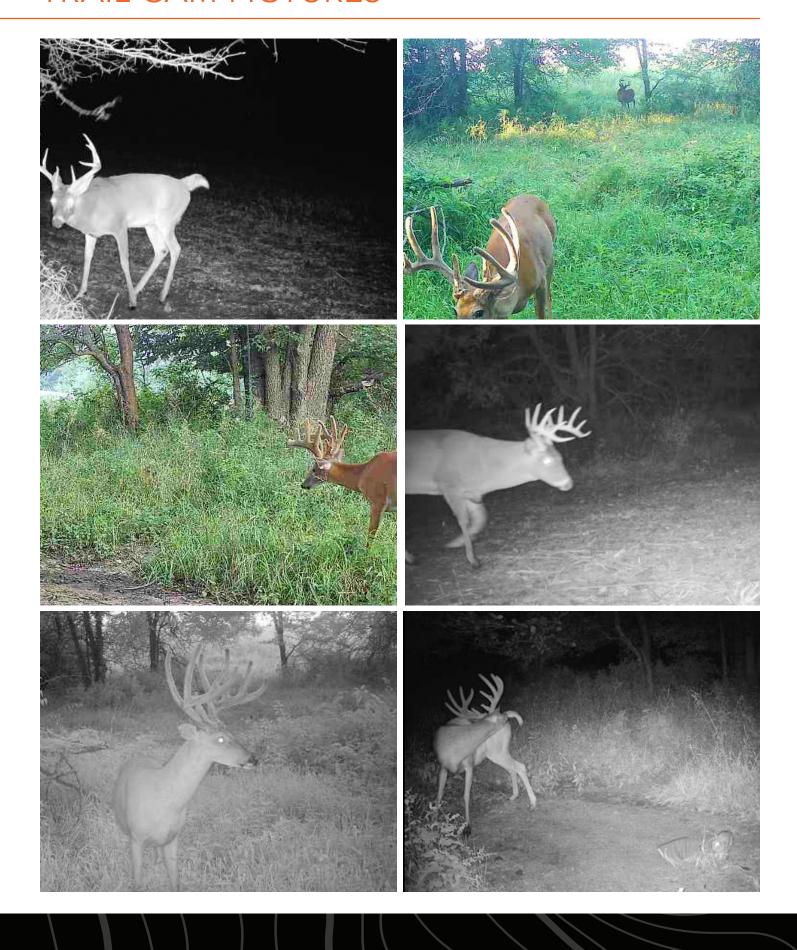

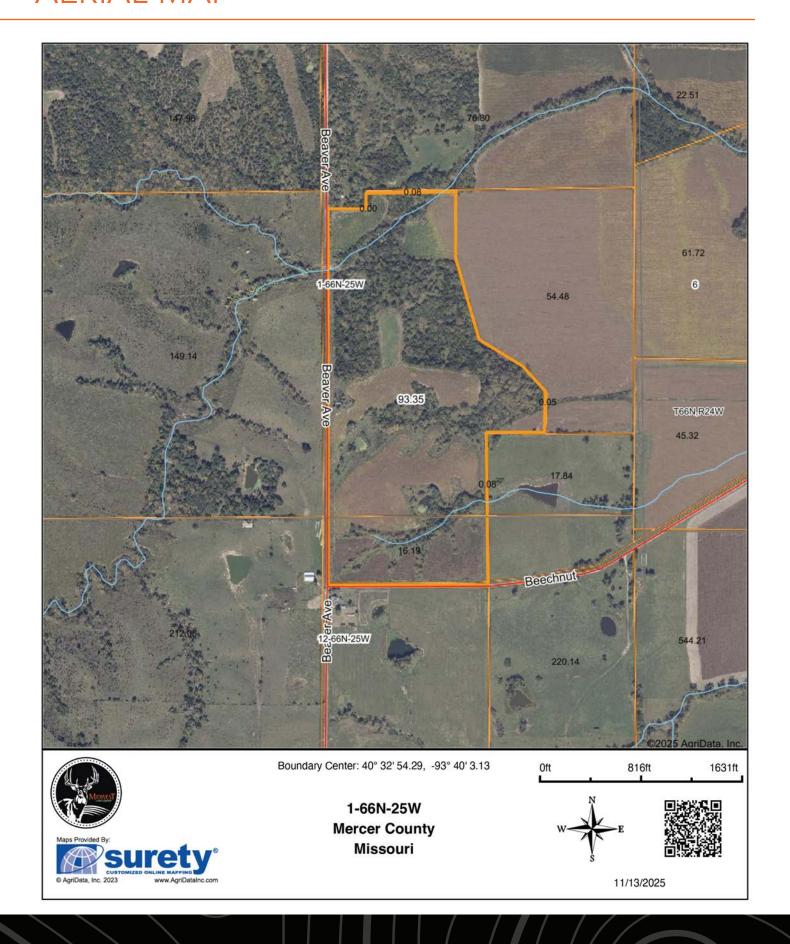

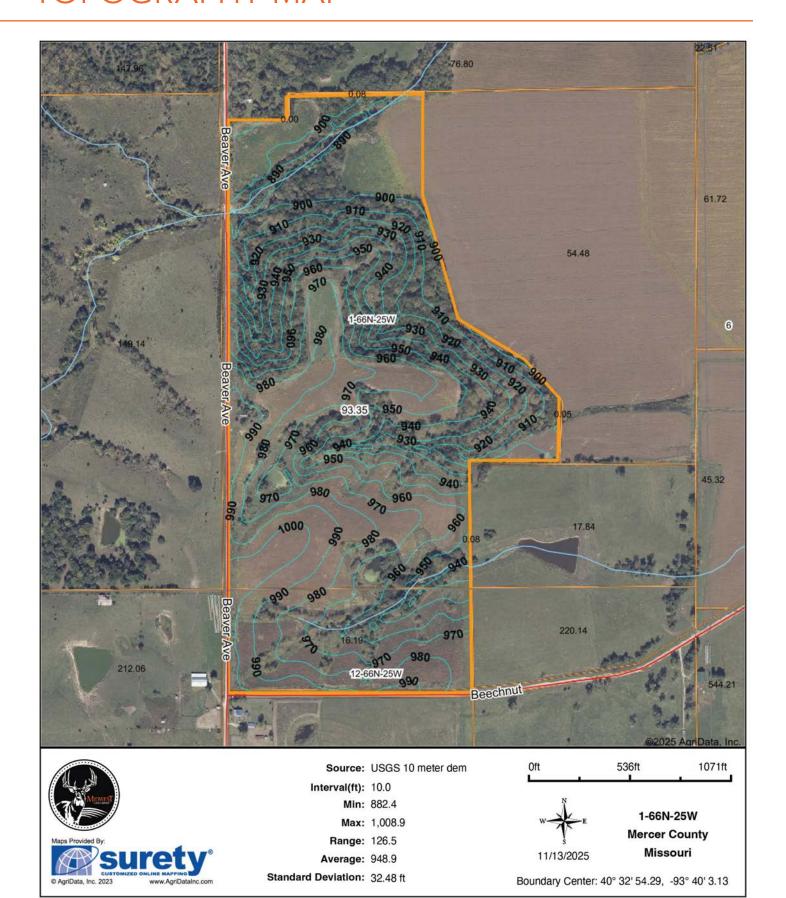

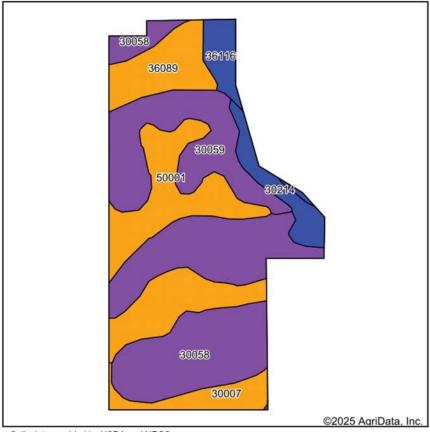
AERIAL MAP

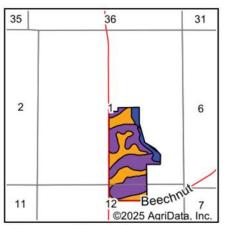


TOPOGRAPHY MAP

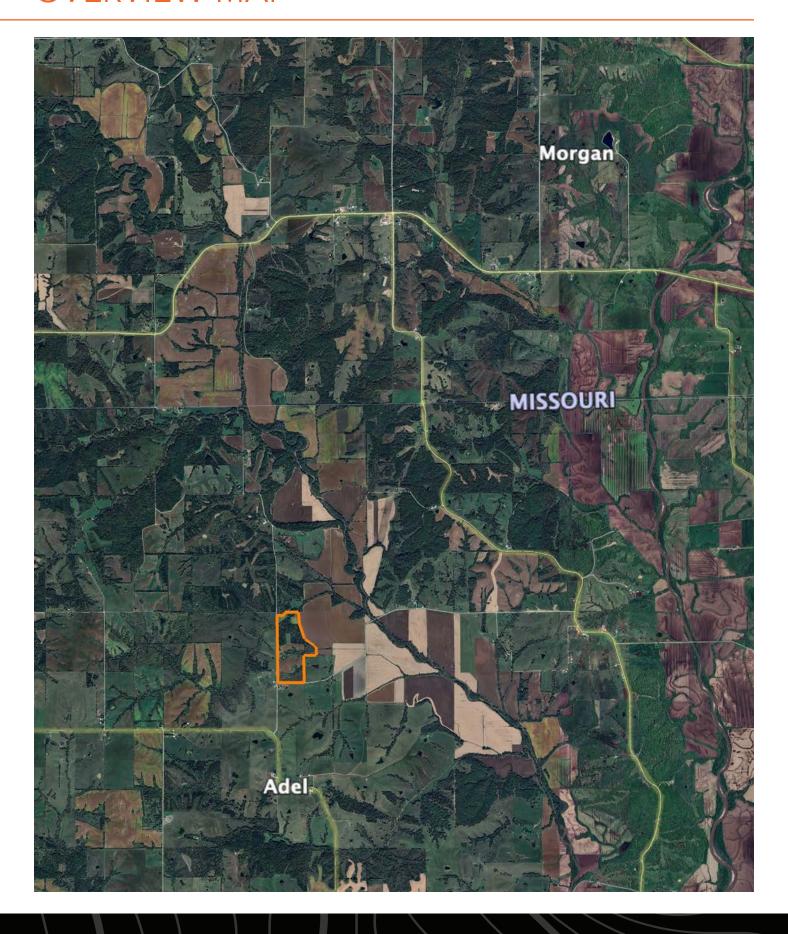
