The main house offers over 2,100 square feet of living space, including a large kitchen/dining area, nursery, wash and laundry rooms, and six bedrooms on the second level. The various buildings on the property present opportunities for multiple sources of enterprise, which is culminated through the included 900 square foot storefront near the front of the property. 






