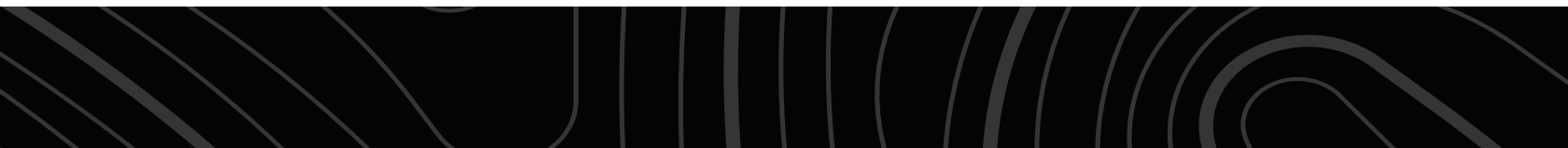
VERNON 530 - ONLINE LAND AUCTION

Midwest Land Group is proud to present this 530 +/- acre row crop farm in western Vernon County for public online auction. The farm will be offered in four tracts, with online bidding to begin August 12th, 2026 and ending August 14th, 2026.

The farm is conveniently located along Highway T, just 1.5 miles south of the ADM biodiesel plant at Eve, Missouri, with highway frontage on 3 of the 4 tracts. All tracts feature Class 2 and Class 3 soils, primarily silt loams, and all are classified as Prime Farmland or Soils of Statewide Importance by the NRCS. Buyers with an interest in hunting will appreciate the opportunities afforded by the wooded draws that meander through some of the tracts.

TRACT 1 - 181.6 +/- ACRES

Tract 1 consists of 181.6 +/- acres and is highly tillable, with approximately 98% of the farm in crop production. Predominant soils on this tract are Parsons silt loam (61.6%), Barden silt loam (24.0%), and Mayes silty clay loam (12.0%). It has an overall NCCPI index rating of 79.2, with the corn rating at 78.0 and soybeans at 68.1. The entire tract is comprised of Class 2 and Class 3 soils.

This tract is bounded by Highway T on the west, Quail Road to the north, and the CPKC railroad to the east. A small stand of trees is present on the east side adjacent to the railroad tracks.

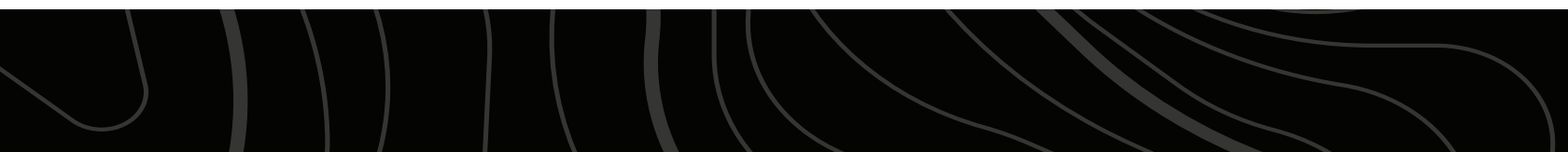

TRACT 2 - 154.8 +/- ACRES

Tract 2 consists of 154.8 +/- acres and is highly tillable, with approximately 83% of the farm in crop production. Predominant soils on the farmed portion of this tract are Parsons silt loam (40.3%), Barden silt loam (38.6%), and Liberal silt loam (10.1%). It has an overall NCCPI index rating of 75, with the corn rating at 73.7 and soybeans at 65.5. The entire tract is comprised of Class 2 and Class 3 soils.

This tract is bounded by Highway T on the west and Highway KK to the south. Approximately 26 acres in the south and southwest part of this tract are wooded, in association with some small unnamed wet weather creeks. Deer sign is abundant along these patches of cover.

Average corn yields for this tract are 132 bushels/acre (2016-2025; high yield 177 bu/acre), and average bean yields are 45 bushels/acre (2009-2024; high yield 53 bu/acre). Tract 2 is currently planted to early beans.

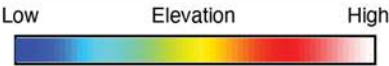
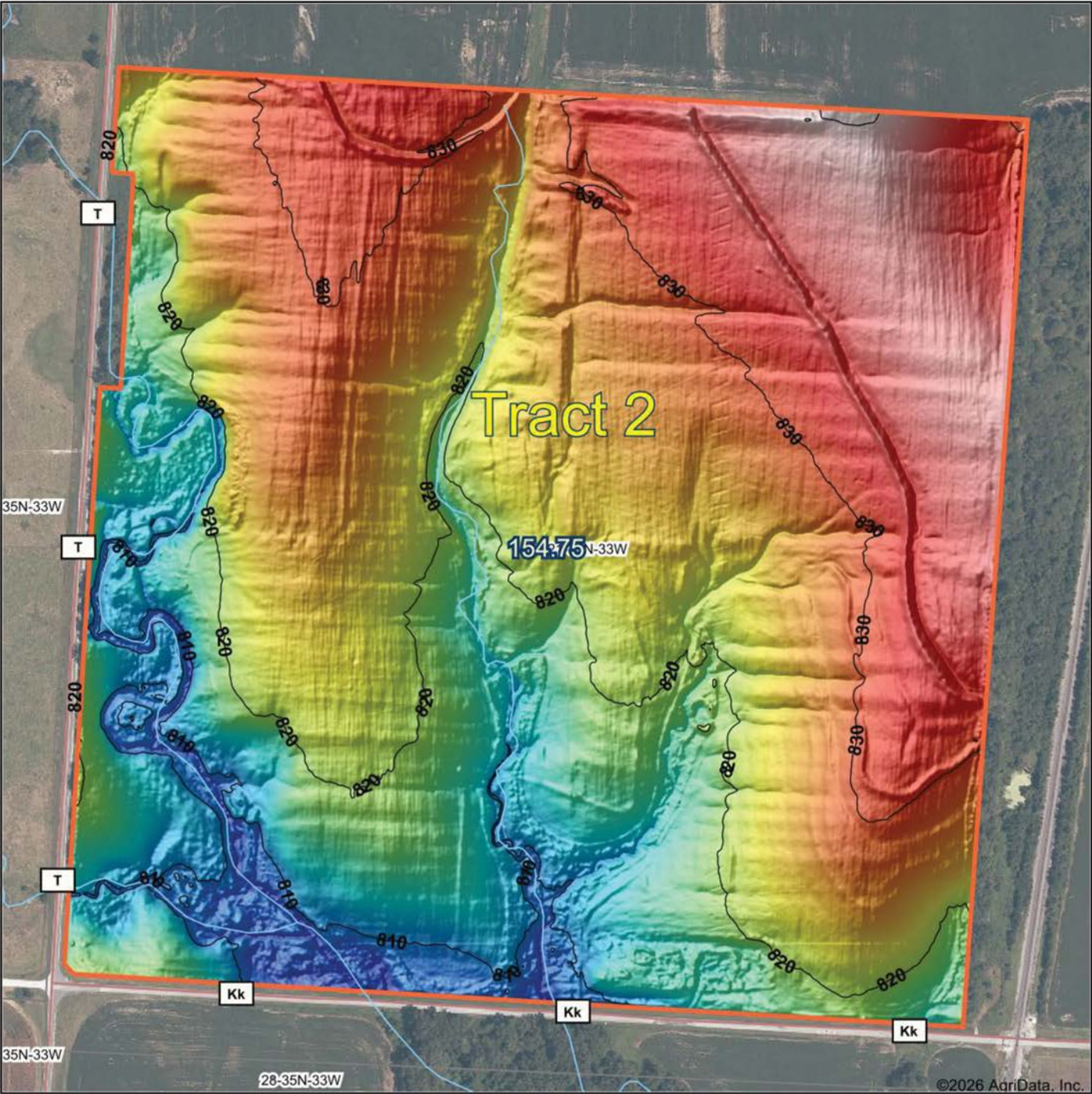

HILLSHADE MAP - TRACT 2



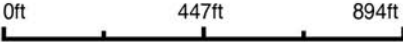

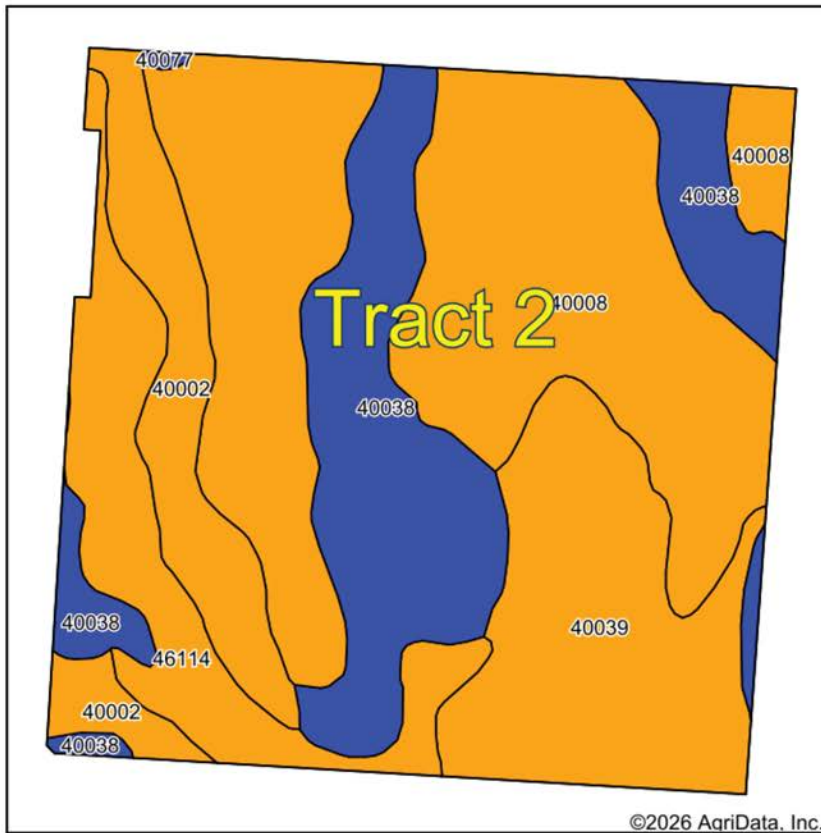

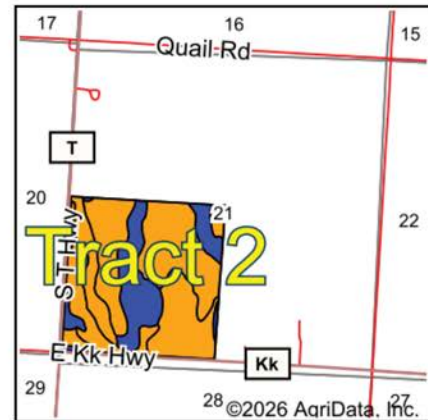

TRACT 3 - 144.3 +/- ACRES

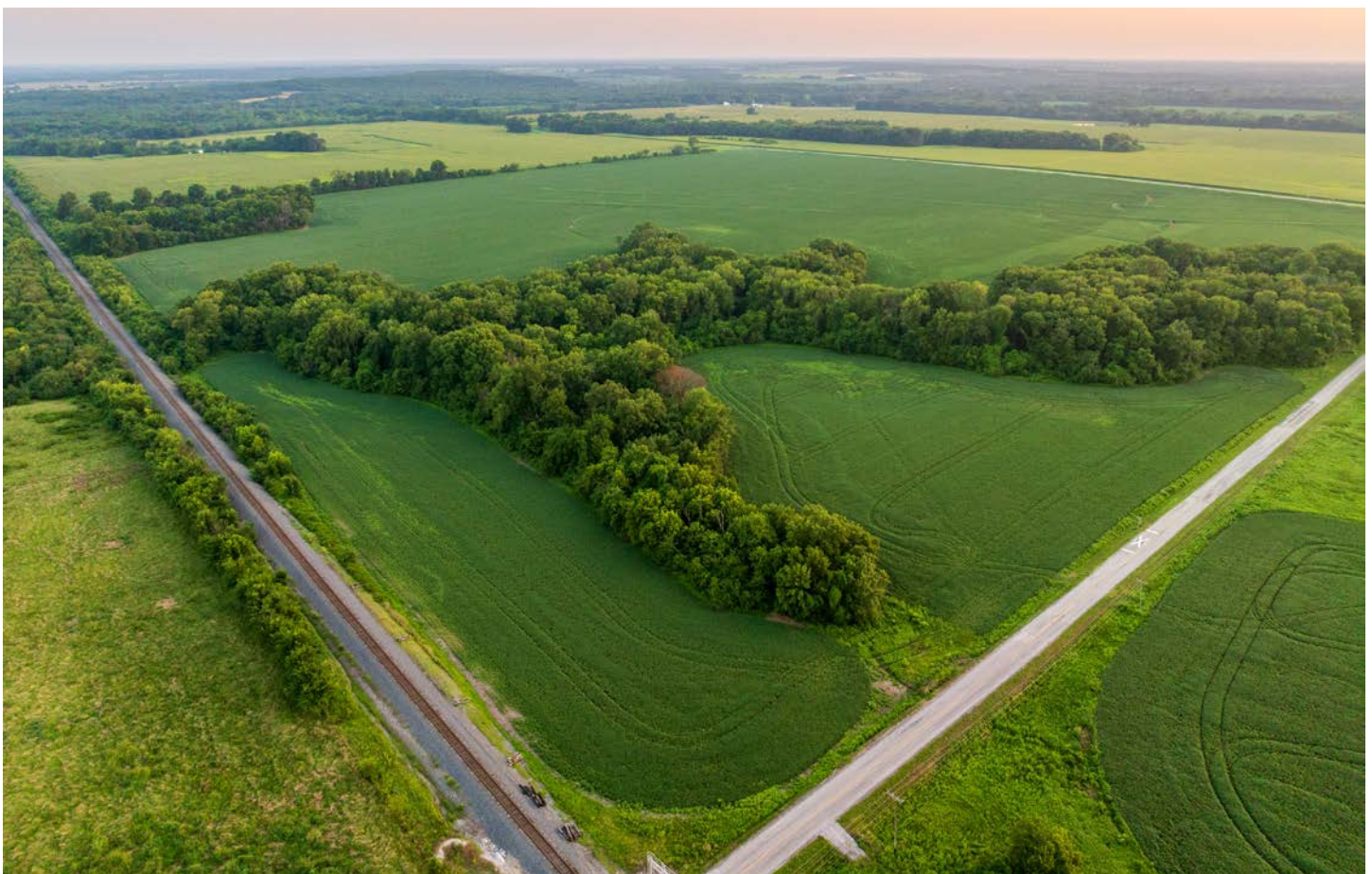
Tract 3 consists of 144.3 +/- acres and is highly tillable, with approximately 119 acres (83%) of the parcel in crop production. Predominant soils on the farmed portion of this tract are Parsons silt loam (48.0%), Liberal silt loam (27.7%), and Barden silt loam (11.7%). It has an overall NCCPI index rating of 74.9, with the corn rating at 73.3 and soybeans at 64.9. The entirety of this tract is Class 2 and Class 3 soils.

This tract is bounded by Highway T on the west, Highway KK to the north, and the CPKC railroad to the east. Approximately 25 acres in the northeast corner of this tract are wooded, in association with some small unnamed wet weather creeks. Deer sign is abundant along these patches of cover.

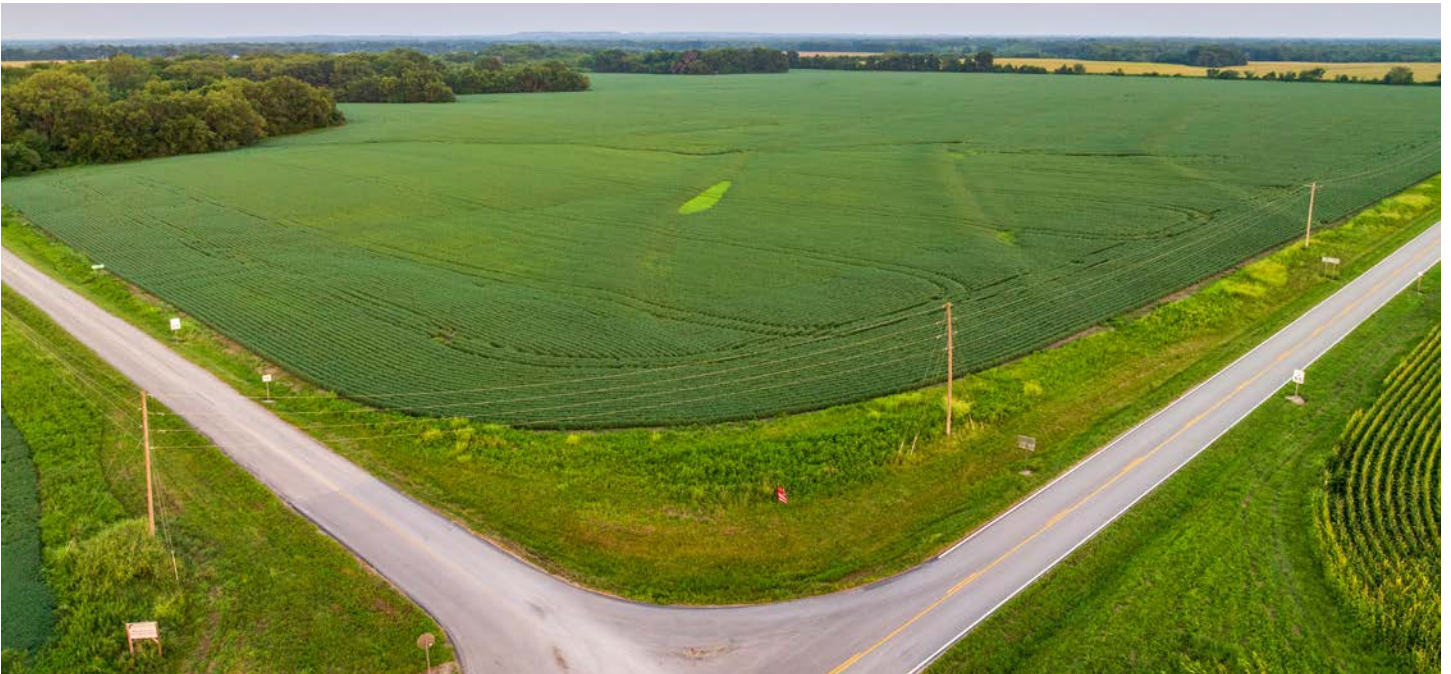

TRACT 4 - 144.3 +/- ACRES

Tract 4 consists of 49.0 +/- acres and is mostly tillable, with approximately 81% of the farm in crop production. Predominant soils on the farmed portion of this tract are Parsons silt loam (45.7%), Mayes silty clay loam (28.7%), and Barden silt loam (15.2%). It has an overall NCCPI index rating of 76.7, with the corn rating at 75.5 and soybeans at 65.8. The entire tract is comprised of Class 2 and Class 3 soils.

This tract is bounded by the CPKC railroad on the west and Quail Road to the north. Approximately 8 acres in the center of this tract is wooded, surrounding a 1-acre pond. Deer sign is abundant along these patches of cover.

Average corn yields for this tract are 132 bushels/acre (2016-2025; high yield 177 bu/acre), and average bean yields are 45 bushels/acre (2009-2024; high yield 53 bu/acre). Tract 4 is currently planted to early beans.
